Affidavit – General Federal Law and Migration proceedings

- 1. This affidavit form should be used for any proceeding which is subject to the:
 - a. Federal Circuit and Family Court of Australia (Division 2) (General Federal Law) Rules 2021 (**the** *Rules*); or
 - b. Federal Circuit and Family Court of Australia (Division 2) (Bankruptcy) Rules 2021.

You must identify the type of proceedings this affidavit is being used for on page 1 of the form.

- 2. Affidavits must comply with the formal requirement for documents (rr .2.01, 15.12 and 15.13 of the Rules).
- 3. Each paragraph in this affidavit must be numbered (r 15.12 of the Rules).
- 4. This affidavit must be sworn or affirmed before a person authorised by law to witness the swearing of affidavits; for example, a lawyer, notary public or Justice of the Peace.
- 5. Each page must be signed by the deponent (the person making the affidavit) (r 15.13(1) of the Rules) and the witness.
- Any handwritten alteration to the affidavit must be initialled by the deponent and the witness (r 15.13(3) of the Rules).

 - b. the details in Part D specifying by whom the affidavit was prepared. This must be completed even if the affidavit was prepared by you, the witness or any other person.
- 9. If there is more than one annexure, you must refer to each by a number or letter, for example 'Annexure 1' or 'Exhibit 1', 'Annexure A' or 'Exhibit A'.
- 10. An annexure should also have page numbers. If there is more than one annexure, the page numbers must run consecutively from the beginning of the affidavit until the last page of the last annexure (r 15.15(4) of the Rules).
- 11. A document annexed or exhibited to an affidavit must be served with an affidavit (r 15.15(6) of the Rules).
- 12. Each annexure or exhibit must include a statement signed by the witness identifying the annexure as the document referred to in this affidavit. The wording of the statement is as follows:

This is the document referred to as [*insert annexure identification*] in the affidavit of [*insert deponent's name*] sworn/affirmed at [*insert place*] on [*insert date*] before me [*witness to sign and provide name and qualification*].

The statement must be signed at the same time as the affidavit and by the same witness. (rr 15.15(3)(b) or 15.15(5)(c) of the Rules)

- 13. The Court may strike out any material which cannot be used in evidence; for example, if the material is unnecessary, scandalous or contains opinions of persons not qualified to give them (r 15.16 of the Rules).
- 14. If the deponent does not understand English, a translator must read or give in writing a translation of the affidavit and the oath/affirmation in a language which is understood, and must certify in the signing clause that they have done so. **Part E** of this form must be used. (r 15.14(3) of the Rules)
- 15. Once complete, an affidavit and its annexures must be filed as one document with the Court using <u>eLodgment</u>, or if unable to be electronically filed, filed in-person.
- 16. You will need to serve a copy of the affidavit and any annexures or exhibits on all other parties (rr 6.03, 6.11 and 6.12 of the Rules). You should keep a copy for your records.
- 17. If your affidavit does not comply with these instructions, the affidavit may not be read into evidence in the proceedings.


